JACKSON COUNTY ORDINANCE NO. 156
"AN ORDINANCE TO SET THE SPEED LIMIT ON COUNTY ROAD
296th AVENUE T87N, R3E, SECTIONS 13 & 12, T87N, R4E, SECTIONS
7 & 18 FROM THE SOUTH SECTION LINE OF SECTION 13, OF
PRAIRIE SPRINGS TOWNSHIP TO THE INTERSECTION OF 296th
AVENUE AND CENTERVILLE ROAD, (COUNTY HIGHWAY D53)
SHALL BE POSTED 35 MPH "

WHEREAS, the Board of Supervisors of Jackson County, Iowa realizes that some locations in the County require lower speed limits than those set by State Legislature, and

WHEREAS, in accordance with section 321.285 of the Code of Iowa, an engineering study and traffic investigation at this location was conducted by the Jackson County Engineer, and

WHEREAS, the Jackson County Board of Supervisors has received the County Engineer's recommendation concerning the speed limit at this location and concurs with said recommendation:

NOW THEREFORE BE IT RESOLVED by the Jackson County Board of Supervisors that the following speed limit be and are hereby set ON COUNTY ROAD 296th AVENUE T87N, R3E, SECTIONS 13 & 12, T87N, R4E, SECTIONS 7 & 18 FROM THE SOUTH SECTION LINE OF SECTION 13, OF PRAIRIE SPRINGS TOWNSHIP TO THE INTERSECTION OF 296th AVENUE AND CENTERVILLE ROAD, (COUNTY HIGHWAY D53) SHALL BE POSTED 35 MPH "

BE IT FURTHER RESOLVED that the County Engineer of Jackson County, Iowa, be directed to place signs setting the assigned speed limit of 35 MPH on COUNTY ROAD 296th AVENUE T87N, R3E, SECTIONS 13 & 12, T87N, R4E, SECTIONS 7 & 18 FROM THE SOUTH SECTION LINE OF SECTION 13, OF PRAIRIE SPRINGS TOWNSHIP TO THE INTERSECTION OF 296th AVENUE AND CENTERVILLE ROAD, (COUNTY HIGHWAY D53)

The County Engineer will give proper notification to all concerned parties.

BE IT FURTHER RESOLVED that any violation of this ordinance shall be a scheduled violation as provided in Section 805.8 (G) Iowa Code 1999
