#### ASAC – Sarah Wright, Prevention Specialist

Sarah Wright presented a power point on Vaping.

#### ASAC - Julie Furne, DFC Grant Project Coordinator

Julie Furne gave an update on the Opioid Settlement. There will be a two-day ISAC Summit in Des Moines on March 24-25. They will be discussing how the money from the settlement can be spent. An update was given on grants being currently written.

#### Community Health – Jen Warren, RN

Jen Warren gave an update on Public Health Services. Doctor's offices may now charge for Covid Vaccines. Warren gave an update on the Health Improvement Plan that is being written. Warren will also be featured on an upcoming radio show discussing food borne illness. Furne and Hobb will be presenting on Safety in the Home

at the Senior Center. Warren will be relinquishing her current office space.

# Hillcrest Family Services – Cynthia Kaczinski, WIC Coordinator

Cynthia Kaczinski gave an update on the Farmer's Market Vouchers available to WIC recipients. Benefits are eligible for anyone enrolled in WIC through September. The vouchers are first come, first served. The vouchers will be worth \$30.00 and can be used anywhere in the state.

#### Environmental Health – Elizabeth Townsend

Elizabeth Townsend gave an update on staffing for the Jackson County Health Department. There has been an increase in work for the Health Department and an administrative assistant will be shared between the Jackson County Zoning and Jackson County Health Departments. Townsend also gave an update on receiving her Time of Transfer Certification through the DNR. Townsend stated that all the money has been spent from the Grants to Counties for this year. The soil testing and water testing program have been successful. Townsend also gave an update on violation notices.

# Unfinished Business – 49197 Green Island Road and 49130 Green Island Road

An update was given by Townsend. Discussion followed about EIRUSS and the potential of putting a sewer system like the system at Leisure Lake in the Green Island area.
