# <u>lowa HHS-Environmental & Local Public Health Bureau Division of Public Health-Roxanne Smith</u>

Roxanne Smith introduced herself. She is taking over Becky Nowachek's position and will be the acting representative for our region. Roxanne has fifteen years of experience in public health on the local level and accepted the position with HHS last fall.

#### ASAC - Reported by Jen Warren on Behalf of Julia Furne

Warren presented an update on the Jackson County Prevention Coalition on behalf of Julia Furne. The coalition purchased an additional medication drop box for the new jail. Some other highlights were that the coalition will be offering NARCAN Trainings open to anyone at no cost and would like to get employees trained. Also tamper strips for alcohol bottles to address the local condition of kids getting alcohol will be made available.

### Community Health - Jen Warren, RN

Warren presented an update on community health. Warren has completed several training sessions including stop the bleed, basic life safety. First aid, heart saver, and friends and family. Warren presented a report from lowa Health and Human Services regarding Jackson County. Warren presented information on the most recent LEPPC meeting, including meeting minutes, and discussed county assessment and surveillance. A full report is available in the meeting packet.

#### **Environmental Health – Elizabeth Townsend**
