MINUTES - August 25, 2025 Meeting

DOCKET 24-13 – Special Exception (Extension from August 26, 2024)

Proposal: Extension of the previously approved special exception for reduced setbacks related to a residential structure.

Chair Nickeson opened the public hearing and summarized the request. The applicant, Doug Waller, presented an update on construction progress.

Applicant Presentation

Mr. Waller reported the following:

- Walls and roof sheeting are installed.
- Windows and doors are onsite and scheduled for installation this week.
- Awaiting concrete contractor to pour garage floor before finishing front framing.
- Metal siding is scheduled.
- Electrical contractor is expected within two weeks.
- HVAC contractor is lined up, and heat will be installed prior to winter.
- Construction delays were due largely to weather and performing most work himself.
- The structure is being built for his parents.
- Estimated move-in timeframe is late October or early November, but significant work remains.

Board members discussed realistic timelines given the amount of work and upcoming weather.
