

PUBLIC NOTICE OF CITY-SCHOOL ELECTION
FOR JACKSON COUNTY ON NOVEMBER 4, 2025

PUBLIC NOTICE IS HEREBY GIVEN to all eligible and qualified electors of Jackson County, State of Iowa, that a City-School Election shall be held for said County on November 4, 2025. Said election shall be conducted according to Chapters 43, 47, 48, 49, 50, 52, 53 and 56 of the Code of Iowa as amended.

FURTHER PUBLIC NOTICE is hereby given that the following thirteen (13) precincts and polling locations shall be used for said election in addition to the designated absentee polling place.

ALL POLLING PLACES in Jackson County are accessible to the disabled person. Any voter who is physically unable to enter a polling place has the right to vote in the voter’s vehicle. For further information, please contact the Jackson County Auditor’s Office at 563-652-3144 or e-mail auditor@jacksoncounty.iowa.gov. Other necessary accommodations shall be available upon request as required by Federal and State laws.

POLLING PLACE HOURS for the regular thirteen precincts during said election shall be from seven o’clock (7:00) a.m. until eight o’clock (8:00) p.m.

VOTING FOR CITY AND SCHOOL CANDIDATES shall be by use of Unisyn OpenElect Voting equipment. All voters shall vote on a paper ballot. An OpenElect FreedomVote Scan, precinct count voting

machine, shall be used at said election to cast ballots. An OpenElect FreedomVote Tablet, a ballot marking device, shall be available to assist disabled voters.

VOTING MACHINE TESTING shall begin on Wednesday, October 22, 2025 at 9:00 a.m. – 4:00 p.m. and will continue until all machines are tested.

THE POST ELECTION AUDIT of a randomly chosen precinct by the Secretary of State’s Office will be conducted in the Jackson County Courthouse basement at 1:00 p.m. on Thursday, November 6, 2025. This is open to the public.

PRE-REGISTERED VOTERS ARE REQUIRED TO PROVIDE an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter’s identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor’s office by 12:00 p.m. on Monday, November 11, 2025. Election Day Registrant attestors must provide an approved form of identification. ABSENTEE BALLOTS MAY BE CAST by registered voters through Monday, November 3, 2025 in the Auditor’s Office at the Courthouse located at 201 West Platt Street, Maquoketa, Iowa, during regular weekdays from 8:30 a.m. to 4:30 p.m. As an alternative method, upon a submission of a written application with the necessary information and written signature, an absentee ballot will be sent by U.S. Mail to the qualified voter. Deadline to request an absentee ballot to be mailed is Monday, October 20, 2025 by 5:00 p.m. Deadline for absentee voting in person is Monday, November 3, 2025 by 4:30 p.m. and ballots returned by mail must be received in the Auditor’s Office by close of the election at 8:00 p.m. on Tuesday, November 4, 2025.

ELECTION DAY REGISTRATION at the polling place for the precinct you currently live in will require proof of residence with a current address in the precinct and identity with a photo ID and if you register after Monday, October 20, 2025 pre-registration deadline. You may vote in the Auditor’s Office after the voter pre-registration deadline, and you will follow the Election Day registration procedure. You will fill out voter registration form, show your proof of residence and identity, sign an oath, and be given an absentee ballot to vote. The best form of ID is a valid Iowa driver’s license with current address. Contact the Auditor’s Office if more information is needed regarding Election Day Registration.

ALL QUALIFIED ELECTORS ARE HEREBY NOTIFIED TO APPEAR AT THE POLLING PRECINCT IN WHICH THEY CURRENTLY RESIDE to cast their ballot for the November 4, 2025 City-School Election, during the aforesaid hours, and at the aforesaid precinct and polling locations.
