PUBLIC NOTICE IS HEREBY GIVEN to the qualified electors of the Dubuque Community School District, in the Counties of Dubuque, and Jackson, State of Iowa, that a special school election has been called and ordered held in and for said school district on September 8, 2026, where at there will be submitted to said electors, one public measure question for Public Measure HC and the School Board of Director At-Large vacancy.

THE POLLS FOR SAID COMMUNITY SCHOOL shall open at seven (7) a.m. o'clock and shall close at eight (8) o'clock p.m. All voters shall vote a paper ballot. An OpenElect FreedomVote Scan, precinct count voting machine, shall be used at said election to cast ballots. An OpenElect FreedomVote Tablet, a ballot marking device, shall be available to assist disabled voters.

THE FOLLOWING POLLING PLACE shall be used for said election. Said polling place is accessible to disabled voters and does comply with ADA regulations. For further information, please contact the county auditor's office at the telephone number or E-mail address listed below.

VOTING MACHINE TESTING shall begin on Thursday, August 27, 2026, at 9:00 a.m. and will continue until all machines are tested.

PRE-REGISTERED VOTERS are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered, such as voters registering to vote on election day and voters changing precincts, must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) may cast a provisional ballot and provide proof of identity/residence at the county auditor's office by Noon on Monday September 14, 2026. Election Day Registrants may use an attester from that precinct, but attestors must provide an approved form of identification. ABSENTEE BALLOTS MAY BE CAST by registered voters through Friday, September 4, 2026 in the Auditor's Office at the Courthouse located at 201 West Platt Street, Maquoketa, Iowa, during regular weekdays from 8:30 a.m. to 4:30 p.m. As an alternative method, upon a submission of a written application with the necessary information and written signature, an absentee ballot will be sent by U.S. Mail to the qualified voter. Deadline to request an absentee ballot to be mailed is Monday August 24, 2026. Deadline for absentee voting in person is Friday, September 4, 2026 by 4:30 p.m. Ballots must be received to the County Auditor by 8:00 p.m. on Election Day, September 8, 2026.

ELECTION DAY REGISTRATION at the polling will require proof of residence with a current address in the precinct and identity with a photo ID and if you register after August 24, 2026 pre-registration deadline. You may vote in the auditor's office after the voter pre-registration deadline, and you will follow the election day registration procedure. You will fill out a voter registration form, show your proof of residence and identity, sign an oath and be given an absentee ballot to vote. The best form of ID is a valid Iowa driver's license with current address. Contact the Auditor's Office if more information is needed regarding Election Day Registration.

ALL QUALIFIED ELECTORS of said school residing in said district are hereby notified to appear on the date and during the aforesaid hours of said election.
