Commencing at the SE Corner of Sec. 14, T85N, R1E; thence west 1325.0 ft.; thence S 1° 0'W 710.0 ft. to the point of beginning; thence N 1° 00'E 1158.8 ft.; thence N 61° 45'W 231.0 ft.; thence N 42° 30'W 330.0 ft.; thence N 71° 30'W 185.0 ft.; thence N 88° 00'W 257.4 ft.; thence N 75° 00'W 270.6 ft.; thence N 21° 00'W 528.0 ft.; thence N 1° 30'E 673.2 ft. to the southerly right of way line of the Emeline to Crab Town Road.

WHEREAS, no objections have been received, either in writing or by persons present, and

WHEREAS, said part of present right of way is no longer necessary or required for use by the public for highway purposes and will not hereafter be required for construction or maintenance purposes for any highway; and

WHEREAS, BE IT RESOLVED by Jackson County that said part of present right of way herein described, together with any and all rights of Jackson County in and to the same are hereby abandoned, and Jackson County hereby disclaims any right, title or interest in and to said part of present right of way or to the use thereof for any purpose whatsoever.

NOW, THEREFORE BE IT RESOLVED by the Jackson County Board of Supervisors, that the subject section of road be ordered vacated and closed.
