

RESOLUTION #224A-30-87

WHEREAS, The Code of Iowa 1987, section 425.2 has been amended per House File 374 to allow a person that has failed to file a claim for homestead by July 1 of the year to file the belated claim with the assessor on or before December 31 of the following calendar year and, if approved by the board of supervisors the county treasurer shall file an amended certificate of homestead tax credits with the director of revenue and finance pursuant to section 425.4.

WHEREAS, the Jackson County Assessor has approved the addition of 1986 homestead tax credit payable in 1987-88 and 1987 homestead tax credit payable 1988-89.




