

RESOLUTION #256-2-26-91

WHEREAS, the Code of Iowa, 1991, section 425.2 allows a person to file a claim for homestead credit before July 1 of the year for which the person is first claiming the exemption or a belated claim shall be filed with the assessor on or before December 31 of the following calendar year and, if approved by the board of supervisors the county treasurer shall file an amended certificate of homestead tax credits with the director of revenue and finance pursuant to section 425.4.

WHEREAS, the Jackson County Assessor has approved the addition of 1989 homestead tax credit payable in 1990-91.

NOW, THEREFORE, BE IT RESOLVED by the Jackson County Board of Supervisors that the following homestead tax credit applications be approved and direct the county treasurer to file an amended certificate of homestead tax credits with the director of revenue and finance pursuant to section 425.4:
