

RESOLUTION #1084-12-03-2024

AWARDING OF TSIP DESTINATION LIGHTING PROJECT
L-TSF-C049(95)—74-49

WHEREAS, on April 23, 2024, the Board of Supervisors, hereafter referred to as "The Board", adopted Resolution #1027-04-26-2024 accepting Funding Agreement No. 2025-TS-012 from the Iowa Department of Transportation in the amount of \$148,500 for the destination lighting installation, hereafter referred to as "The Project", at the following five intersections:

1. Bernard Road (Y31) and West Bellevue Cascade Road
2. 395th Avenue and 308th Street
3. Iowa 62 and Rockdale Road
4. U.S. 61 and 63rd Street
5. Caves Road (Y31) and 172nd Avenue

WHEREAS, the estimated cost of The Project does not exceed the competitive bid threshold as provided in Iowa Code Section 26.3; and

WHEREAS, competitive quotes for The Project were solicited on November 06, 2024; and

WHEREAS, competitive quotes were publicly received, opened, and read aloud on November 27, 2024 at 10:00 AM in the office of the County Engineer at 201 West Platt Street, Maquoketa, Iowa, and the following quotes were received:

Stickley Electric	\$69,235.50
Biechler Electric	\$90,748.74

WHEREAS, The Project's solicited proposal required Targeted Small Business (TSB) documents to be completed and included with contractor's submitted competitive quote; and

WHEREAS, after consultation of the quotes received with the Iowa Department of Transportation, the required completed Targeted Small Business (TSB) documents were not included with the competitive quote received from Stickley Electric; and

WHEREAS, the required completed Targeted Small Business (TSB) documents were included with the competitive quote received from Biechler Electric; and

WHEREAS, omission of required completed Targeted Small Business documents is cause for rejection of competitive quote received from Stickley Electric.

IT IS THEREFORE RESOLVED by The Board to reject the competitive quote from Stickley Electric and to accept the competitive quote from Biechler Electric in the amount of \$90,748.74 and awards the associated contract to the same, and authorizes the Board Chair to execute the form of contract; and

BE IT FURTHER RESOLVED that all other resolutions or parts of resolutions in conflict with this resolution are hereby repealed. If any part of this resolution is adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the resolution or action of the Board as a whole or any part thereof not adjudged invalid or unconstitutional. This resolution shall be in full force and effect from and after the date of its approval as provided by law.
