AREA SERVICE "B" ROAD CLASSIFICATIONS

WHEREAS, Jackson County desires to classify certain roads on the area service system in the County to provide for a minimal level of maintenance; and

WHEREAS, Jackson County, after consultation with the County Engineer, has the authority to specify certain roads within the County as Area Service "B" roads pursuant to Iowa Code 309.57; and

WHEREAS, the Jackson County Board of Supervisors, after consulting with the Jackson County Engineer, desire to designate various roads in Jackson County on the Area Service "B" System to provide for a reduced level of maintenance in order to best utilize maintenance funds; and

WHEREAS, the following roads be classified as an Area Service "B" road:

21st Street

Located in Monmouth Township T84, R1E, Section 29 commencing from the intersection with 33rd Avenue (Lat: 42.05148, Long: -90.86735) and proceeding east a distance of 0.38 miles to the easterly section line of Section 29 (Lat: 42.05146, Long: -90.86006);

31st Avenue

Located in Butler Township T86, R1E, Section 8 commencing from 0.63 miles south of the intersection with Bellevue-Cascade Road (Lat: 42.27749, Long: -90.86597), and proceeding west a distance of 0.45 miles to the end of roadway (Lat: 42.27679, Long: -90.87463);

33rd Avenue

Located in Monmouth Township T84, R1E, Section 29 commencing from the intersection with 21st Street (Lat: 42.05148, Long: -90.86735) and proceeding north a distance of 0.92 miles to the intersection with 33rd Street (Lat: 42.06232, Long: -90.86020);

34th Street

Located in South Fork Township T84, R2E, Section 20 commencing from 0.13 miles east of the intersection of IA Highway 64 (Lat: 42.06360, Long: -90.75969), and proceeding east a distance of 0.21 miles to a location 0.03 miles west of the intersection with 123rd Avenue (Lat: 42.06265, Long: -90.75648);

45th Avenue

Located in Brandon Township T85, R1E, Section 22 commencing from 0.03 miles south of the intersection with 150th Street (Lat: 42.15625, Long: -90.84008), and proceeding south a distance of 0.29 miles to the end of roadway (Lat: 42.15210, Long: -90.84018);

58th Avenue

Located in Monmouth Township T84, R1E, Section 22 commencing from the intersection with IA Highway 64 (Lat: 42.07376, Long: -90.83118) and proceeding north a distance of 0.20 miles to the end of roadway (Lat: 42.07659, Long: -90.83124);

67th Avenue

Located in Monmouth Township T84, R1E, Sections 14 and 11 commencing from 0.12 miles north of the intersection with IA Highway 64 (Lat: 42.07727, Long: -90.82140), and proceeding north a distance of 1.38 miles to a location 0.65 miles south of the intersection with 80th Street (Lat: 42.09202, Long: -90.82046);

67th Street

Located in Monmouth Township T84, R1E, Section 17 commencing from 0.18 miles east of the intersection with 17th Avenue (Lat: 42.08439, Long: -90.87676), and proceeding east a distance of 0.09 miles to the west end of the Area Service "C" portion of 67th Street (Lat: 42.08480, Long: -90.87507);

70th Street

Located in Fairfield Township T84, R4E, Section 11 commencing from 0.83 miles west of the intersection with 387th Avenue (Lat: 42.09644, Long: -90.45229), and proceeding north a distance of 0.15 miles, and proceeding west a distance of 0.42 miles to the end of roadway (Lat: 42.09846, Long: -90.46054);

84th Avenue

Located in Monmouth Township T84, R1E, Section 24 commencing from the intersection with 33rd Street (Lat: 42.06203, Long: -90.80181), and proceeding north a distance of 0.75 miles to the intersection with IA Highway 64 (Lat: 42.07263, Long: -90.80082);

90th Street

Located in Monmouth Township T84, R1E, Section 12 commencing from 0.24 miles north of the intersection with 74th Street (Lat: 42.09883, Long: -90.78732), and proceeding north a distance of 0.42 miles to a location 1.38 miles west of the intersection with Caves Road (Lat: 42.10403, Long: -90.78491);

92nd Avenue

Located in Brandon Township T85, R1E, Sections 13 and 24 commencing from the intersection with Bernard Road (Lat: 42.15439, Long: -90.78664), and proceeding northwest a distance of 1.78 miles to the intersection with Bernard Road (Lat: 42.17497, Long: -90.80120);

98th Street

Located in Monmouth Township T84, R1E, Section 1 commencing from the intersection with 82nd Avenue (Lat: 42.11334, Long: -90.80209), and proceeding northeast a distance of 0.91 miles to the intersection with 95th Avenue (Lat: 42.11852, Long: -90.78865);

124th Street

Located in Jackson Township T85, R4E, Section 21 commencing from the intersection with 340th Avenue (Lat: 42.15315, Long: -90.50151), and proceeding east a distance of 0.25 miles to the end of roadway (Lat: 42.15308, Long: -90.49663);

133rd Avenue

Located in Farmers Creek Township T85, R2E, Sections 16, 17, and 21 commencing from the intersection with 150th Street (Lat: 42.16141, Long: -90.74339), and proceeding north a distance of 0.90 miles to the intersection with 162nd Street (Lat: 42.17385, Long: -90.74726);

133rd Street

Located in Washington Township T85, R5E, Section 27 commencing from 0.61 miles east of the intersection with 435th Avenue (Lat: 42.14989, Long: -90.37397), and proceeding east a distance of 0.65 miles to the intersection with 462nd Avenue (Lat: 42.14941, Long: -90.36183);

136th Street

Located in Farmers Creek Township T85, R2E, Sections 26 and 27 commencing from the intersection with Esgate Road (Lat: 42.14244, Long: -90.71457), and proceeding east a distance of 0.75 miles to the intersection with 171st Avenue (Lat: 42.14236, Long: -90.70004);

142nd Street

Located in Farmers Creek Township T85, R2E, Section 22 commencing from 0.25 miles west of the intersection with 162nd Avenue (Lat: 42.15699, Long: -90.71469), and proceeding west a distance of 0.26 miles to the end of roadway (Lat: 42.15705, Long: -90.71986);

146th Street

Located in Brandon Township T85, R1E, Section 24, and Farmers Creek Township T85, R2E, Section 19 commencing from the intersection with Bernard Road (Lat: 42.16083, Long: -90.78528), and proceeding east a distance of 0.39 miles to the end of roadway (Lat: 42.15971, Long: -90.77802);

162nd Avenue

Located in Farmers Creek Township T85, R2E, Section 22 commencing from the intersection with 142nd Street (Lat: 42.15696, Long: -90.70973), and proceeding north a distance of 0.52 miles to the intersection with 150th Street (Lat: 42.16426, Long: -90.70982);

187th Street

Located in Brandon Township T84, R1E, Section 5 commencing from the intersection of 21st Avenue (Lat: 42.19581, Long: -90.87537), and proceeding east a distance of 0.05 miles to the west end of the Area Service "C" portion of 187th Street (Lat: 42.19620, Long: -90.87457);

189th Street

Located in Perry Township T85, R3E, Section 3 commencing from 0.76 miles west of the intersection with 184th Street (Lat: 42.20053, Long: -90.59749), and proceeding west a distance of 0.04 miles to the east end of the Area Service "C" portion of 189th Street (Lat: 42.20055, Long: -90.59818);

189th Street

Located in Perry Township T85, R3E, Section 4 commencing from the intersection of 250th Avenue (Lat: 42.20060, Long: -90.61014), and proceeding east a distance of 0.06 miles to the west end of the Area Service "C" portion of 189th Street (Lat: 42.20057, Long: -90.60898);

203rd Street

Located in Richland Township T86, R3E, Section 32 commencing from the intersection of 216th Avenue (Lat: 42.21090, Long: -90.64656), and proceeding east a distance of 0.51 miles to the end of the roadway (Lat: 42.21000, Long: -90.63708);

206th Street

Located in Butler Township T86, R1E, Section 33 commencing from 0.83 miles west of the intersection with Bernard Road (Lat: 42.21135, Long: -90.85227), and proceeding southwest a distance of 0.37 miles to the end of the roadway at the southerly section line of Section 33 (Lat: 42.20769, Long: -90.85503);

216th Avenue

Located in Perry Township T85, R3E, Sections 19 and 20 commencing from 0.59 miles south of the intersection with 150th Street (Lat: 42.15619, Long: -90.64674), and proceeding south a distance of 0.45 miles to the intersection with 134th Street (Lat: 42.14961, Long: -90.64684);

223rd Avenue

Located in Maquoketa Township T84, R3E, Section 29 commencing from 1.06 miles south of the intersection with IA Highway 64 (Lat: 42.05103, Long: -90.63183), and proceeding southwest a distance of 0.06 miles to the end of the roadway (Lat: 42.05093, Long: -90.63286);

225th Street

Located in Butler Township T86, R1E, Section 29 commencing from 0.22 miles west of the intersection with 20th Avenue (Lat: 42.22948, Long: -90.87491); and proceeding west a distance of 0.25 miles to the end of the roadway (Lat: 42.22946, Long: -90.87986);

232nd Avenue

Located in Prairie Springs Township T87, R3E, Sections 20, 21, 28, and 29 commencing from 0.25 miles north of the intersection with 325th Street (Lat: 42.32020, Long: -90.62729), and proceeding north distance of 0.49 miles to the intersection with 330th Street (Lat: 42.32726, Long: -90.62747);

258th Avenue

Located in Prairie Springs Township T87, R3E, Section 34 commencing from the intersection with Mill Creek Road (Lat: 42.29471, Long: -90.59789), and proceeding north a distance 0.25 miles to the south end of the Area Service "C" portion of 258th Avenue (Lat: 42.29829, Long: -90.59793);

267th Street

Located in Otter Creek Township T86, R2E, Section 8 commencing from 0.49 miles southwest of the intersection with 129th Avenue (Lat: 42.26737, Long: -90.75559), and proceeding south a distance of 0.11 miles to the end of the roadway at the southerly section line of Section 8 (Lat: 42.26581, Long: -90.75605);

283rd Street

Located in Otter Creek Township T86, R2E, Section 12 commencing from 0.09 miles west of the intersection with US Highway 61 (Lat: 42.28055, Long: -90.68070), and proceeding west a distance of 0.23 miles to the end of the roadway at the westerly section line of Section 12 (Lat: 42.28063, Long: -90.68523);

283rd Street

Located in Richland Township T86, R3E, Section 6 and 7 commencing from 0.73 miles east of the intersection with 194th Avenue (Lat: 42.28041, Long: -90.66087), and proceeding east a distance of 0.12 miles to the west end of the Area Service "C" portion of 283rd Street (Lat: 42.28034, Long: -90.65860);

287th Street

Located in Richland Township T86, R3E, Section 3 commencing from the intersection with 250th Avenue (Lat: 42.28375, Long: -90.60424), and proceeding east a distance of 0.31 miles to the intersection with 257th Avenue (Lat: 42.28397, Long: -90.59848);

289th Avenue

Located in Richland Township T86, R3E, Sections 25 and 26 commencing from the intersection with 216th Street (Lat: 42.22391, Long: -90.57039), and proceeding northeasterly a distance of 0.96 miles to the intersection with Bellevue-Cascade Road (Lat: 42.23665, Long: -90.56362);

304th Avenue

Located in Bellevue Township T86, R4E, Section 6, and Tete Des Morts Township T87, R4E, Sections 30 and 31 commencing from 0.64 miles north of the intersection with Mill Creek Road (Lat: 42.29170, Long: -90.54530), and proceeding north a distance of 2.03 miles to a location 0.07 miles south of the intersection with Sieverding Ridge Road (Lat: 42.31799, Long: -90.53719);

308th Avenue

Located in Perry Township T85, R3E, Section 24, and Jackson Township T86, R4E, Sections 18 and 19 commencing from the intersection with 298th Avenue (Lat: 42.15667, Long: -90.55157), and proceeding northwesterly a distance of 1.52 miles to a location 0.38 miles south of the intersection with 167th Street (Lat: 42.17299, Long: -90.53981);

308th Street

Located in Tete Des Morts Township T87, R4E, Section 32 commencing from 0.11 miles east of the intersection with Sieverding Ridge Road (Lat: 42.30585, Long: -90.52781), and proceeding east a distance of 0.98 miles to a location 3.53 miles west of the intersection with US Highway 52 (Lat: 42.30015, Long: -90.51100);

322nd Avenue

Located in Bellevue Township T86, R4E, Section 29 commencing from 0.47 miles south of the intersection with 216th Street (Lat: 42.22765, Long: -90.52604), and proceeding southwesterly a distance of C.25 miles to the end of the roadway at the westerly section line of Section 29 (Lat: 42.22559, Long: -90.52994);

325th Avenue

Located in Bellevue Township T86, R4E, Sections 5 and 8 commencing from the intersection with Mill Creek Road (Lat: 42.27126, Long: -90.51870), and proceeding north a distance of 0.98 miles to a location 0.37 miles south of the intersection with Sieverding Ridge Road (Lat: 42.28425, Long: -90.51503);

342nd Avenue

Located in Jackson Township T85, R4E, Section 33 commencing from the intersection with 100th Street (Lat: 42.13073, Long: -90.50133), and proceeding south a distance of 0.29 miles to the end of roadway (Lat: 42.12666, Long: -90.50127);

380th Avenue

Located in Tete Des Morts Township T87, R4E, Sections 13 and 14 commencing from 0.98 miles north of the intersection with 341st Street (Lat: 42.34222, Long: -90.44448), and proceeding northwesterly a distance of 1.33 miles to the intersection with 370th Street (Lat: 42.34849, Long: -90.46212);

462nd Avenue

Located in Washington Township T85, R5E, Sections 22 and 27 commencing from the intersection with 133rd Street (Lat: 42.14941, Long: -90.36183), and proceeding north a distance 0.20 miles to a location 0.36 miles south of the intersection with 142nd Street (Lat: 42.15227, Long: -90.36179);

484th Avenue

Located in Van Buren Township T84, R5E, Section 1 and Washington Township T85, R5E, Section 36 commencing from 1.02 miles north of the intersection with 75th Street (Lat: 42.11371, Long: -90.33501), and proceeding northeasterly a distance 0.69 miles to the intersection with 495th Avenue (Lat: 42.12228, Long: -90.32941);

500th Avenue

Located in Washington Township T85, R5E, Section 24 commencing from the intersection with Green Island Road (Lat: 42.15358, Long: -90.32195), and proceeding southeasterly a distance of 0.30 miles to a location 2.18 miles northwesterly of the intersection with US Highway 52 (Lat: 42.15191, Long: -90.31770);

501st Avenue

Located in Washington Township T85, R5E, Sections 13, 18, 19, and 24 commencing from the intersection with Green Island Road (Lat: 42.15375, Long: -90.31533), and proceeding north a distance of 1.87 miles to the end of roadway (Lat: 42.18076, Long: -90.31509);

584th Avenue

Located in Iowa Township T84, R6E, Sections 11 and 12 commencing from 0.17 miles north of the intersection with 64th Street (Lat: 42.09326, Long: -90.21774), and proceeding north a distance of 0.27 miles to the south end of the Area Service "C" portion of 584th Avenue (Lat: 42.09712, Long: -90.21753); and

WHEREAS, Area Service "B" Roads shall be subjected to the reduced level of maintenance responsibilities as stated in Jackson County Ordinance No. 315;

WHEREAS, pursuant to Notice of Public Hearing duly published according to the Iowa Code, Public Hearings were held on the 6th day of May, 2025 at 9:20 a.m. and on the 27th day of May, 2025 at 9:00 a.m. in the Board of Supervisors room at the Jackson County Courthouse, Maquoketa, Iowa, to hear support and/or objections from the public on roads so designated.

IT IS THEREFORE RESOLVED by the Jackson County Board of Supervisors that this County does hereby establish the following roads described as an Area Service "B" road, open to traffic with a minimal level of maintenance; and

BE IT FURTHER RESOLVED by the Jackson County Board of Supervisors, that this resolution supersedes and replaces all prior agreements and resolutions with respect to the designation of Area Service System "B" Roads within Jackson County Iowa.
