

RESOLUTION # 244-01-03-06  
Area Service "C" Road Classification for 21<sup>st</sup> Street

Whereas, Jackson County desires to classify certain roads on the area service system in the County to provide for minimal level of maintenance and access by means of a gate or barrier: and

Whereas, the County, after consultation with the County Engineer, has the authority to specify certain road within the County as Area Service "C" roads, pursuant to Iowa Code section 309.57 (1995) as amended by House File 419 (1996): and

Whereas, the County has received a petition, attached to this resolution, signed by all landowners adjoining the road, requesting that the Following road be classified as an Area Service "C" road:

21<sup>st</sup> Street, Section 28 Monmouth Township from the west section line of Section 28, Monmouth Township thence east to the intersection of 21<sup>st</sup> Street with 50<sup>th</sup> Avenue: and

Whereas, the petitioners have agreed and understand the maintenance of all Area Service "C" Roads will be as follows:

1. Blading. Blading or dragging will not be performed on a regular basis
2. Snow and Ice Removal. Snow and ice removal will not be performed. Sanding and salting will not be performed.
3. Bridges, Culverts and Structures. Bridges on Area Service "C" Roads may not be maintained to carry legal loads but will be posted as appropriate to advise of any load limitations. Upon failure or loss, any replacement structures will be for the traffic thereon.
4. Weeds, Brush, and Trees. Mowing, cutting of brush, and tree removal will not be performed on a regular basis. Adequate sight distance will not be maintained on a regular basis.
5. Road Surfacing. There will be no surfacing materials applied to Area Service "C" Roads.
6. Shoulders. Shoulders will not be maintained.
7. Crown. A crown will not be maintained.
8. Repairs. There will be no road repairs on a regular basis.
9. Uniform Width. Uniform width for the traveled portion of the road will not be maintained.
10. Inspections. Regular inspections will not be conducted.
11. The gate shall be purchased and installed by the County and maintained by the adjoining landowners. If not so maintained, the County may remove the gate. The gate shall be locked with keys to the lock provided to all persons who have access rights.


Whereas, the only persons who will have access rights to the road shall be:

1. The owner, lessee, or person in lawful possession of any adjoining land.
2. The agent or employee of the owner, lessee, or person in lawful possession of any adjoining land.
3. Any peace officer.


4. Any magistrate.
5. Any public employee whose duty is to supervise the use or perform maintenance of the road.
6. Any agent or employee of any utility located upon the road.

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF JACKSON COUNTY, IOWA that this County does hereby establish the road described above as an Area Service "C" Road, with restricted access and minimal level of maintenance.
