

RESOLUTION #1016-02-13-2024

AWARD THE PCC 308TH STREET PAVEMENT PROJECT

WHEREAS, the Board of Supervisors, hereafter referred to as "The Board", believes the L-308(24)—73-49 paving project, hereafter referred to as "The Project" is in the best interest of Jackson County, Iowa, and the residents thereof. The Project is defined as PCC Pavement - New on 308th Street from State Highway 52 to 0.30 Miles West; and

WHEREAS, in accordance with Iowa Code Section 26.12, a public hearing was held on January 16, 2024 to approve the proposed plans, specifications, form of contract, and cost estimate for The Project; and

WHEREAS, a resolution was adopted by the Board on January 16, 2024 approving the proposed plans, specifications, form of contract, and cost estimate for The Project; and

WHEREAS, in accordance with Iowa Code Section 26.3, a Notice to Bidders was advertised for sealed bids for The Project on January 16, 2024; and

WHEREAS, in accordance with Iowa Code Section 26.10, a public bid opening for The Project was conducted on February 8, 2024 at 10:00 AM in the office of the County Engineer at 201 West Platt Street, Maquoketa, Iowa, and the following bids were received:

Tschiggfrie Excavating Co.	\$273,382.00
Boomerang Corporation	\$286,132.50
Eastern Iowa Excavating	\$286,358.64
Midwest Concrete Inc.	\$298,700.11
Ihrig Works LLC	\$347,204.35

WHEREAS, The Board finds this resolution appropriate and necessary to protect, preserve, and improve the rights, privileges, property, peace, safety, health, welfare, comfort, and convenience of Jackson County and its citizens, all as provided for in and permitted by section 331.301 of the Code of Iowa.




