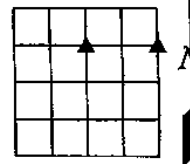

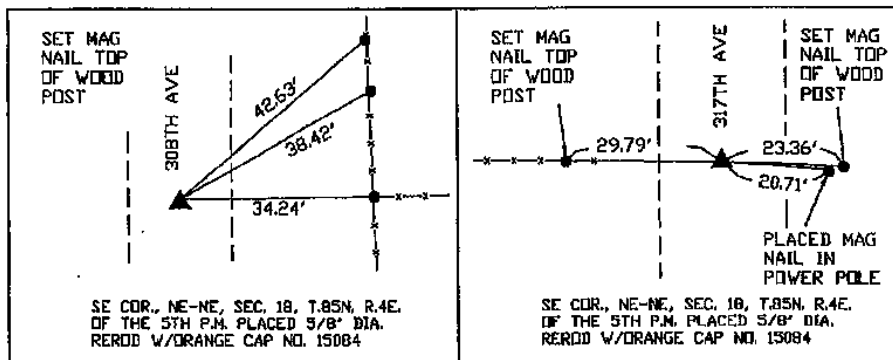

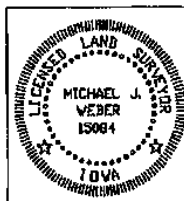
PLAN - VIEW
